### Your rights

### Compensation

This scheme provides compensation in case any of its members go out of business or into liquidation and are unable to meet any valid claim under its policies. The first £2,000 of a claim is protected in full. Above this threshold, 90% of the remainder of the claim will be met. For compulsory classes of insurance, 100% of the claim will be met without any upper limit.
